7. Recommended Changes to SUCSAC Constitution and Bylaws (Discussion/Action Item)

An in-depth discussion occurred regarding potential changes to the SUCSAC Constitution and Bylaws. Two proposals were reviewed for renumbering of Articles, Sections, and Subsections, one presented by Shari and one presented by Michael. Motion was made by Peter to accept Draft 1's renumbering and grammatical changes as presented by Shari. Motion was seconded by John. Roll call vote to accept Draft 1 of the renumbering and grammatical changes: Ayes: Shari, John, and Peter. Nay: Michael. Abstain (due to early departure of members): Shauna and Clay. Quorum was still present so motion passed.

Other proposed changes (primarily needed to keep SUCSAC in compliance with the Open Meetings Act and to avoid having meetings within a meeting) included topics surrounding:
