Change-In-Title Policy requirement reflects procedure issued 12/23/03. Using Change-In-Title procedures and dependent upon job duties for each position or audit findings, Laboratory Animal Care Series positions should be moved to the appropriate Laboratory Animal Care Series or Laboratory Animal Care Coordinator classification.

Voiding/Deleting Registers

The registers for the Laboratory Animal Caretaker, Laboratory Animal Care Technician I, II, Supervisor of Laboratory Animal Care and Coordinator of Laboratory Animal Care should be *void* at the close of business July 14, 2004. All testing materials related to these titles should be destroyed. The revised class specifications and examining instruments for the Laboratory Animal Caretaker, Laboratory Animal Care Specialist, Laboratory Animal Care Supervisor and Laboratory Animal Care Supervisor and Laboratory Animal Care Coordinator will be effective July 15, 2004.

Instruments by Class

Revised Instrument by Class pages will be distributed to each university/agency.

Pay Rate/Ranges

Where necessary, universities/agencies should make adjustments or establish new pay rates/ranges to accompany the above changes. In some instances, establishing a wide pay range will optimize the opportunity of each university/agency to properly reflect their individual compensation programs for these operations and positions.

Seniority

Ensure that seniority calculations for both the Laboratory Animal Care Supervisor and the Laboratory Animal Care Coordinator classifications are accurate.
