Change-In-Title Policy requirement reflects revised procedures issued 12/23/03. The actions listed above are recommended. Based on job duties and responsibilities, positions should be identified and moved simultaneously to the appropriate new classifications.

Voiding/Deleting Registers

The registers for the Ticket Specialist I (Athletics) and Ticket Specialist III (Athletics) should be deleted at the close of business on October 31, 2005. The registers for the Ticket Specialist II (Athletics), Ticket Specialist IV (Athletics) and Ticket Control Supervisor should be voided at the close of business on October 31, 2005. All testing materials related to these titles should be destroyed. The new/revised class specifications and examining instruments for the Ticket Sales Assistant, Ticket Sales Specialist and Ticket Sales Supervisor will be effective November 1, 2005.

Pay Rate/Ranges

Where necessary, employers should make adjustments to or establish new pay rates/ranges to accompany the above changes. In some instances, establishing a wide pay range will optimize the opportunity of each employer to properly reflect their individual compensation programs for these operations and positions.

Seniority

Dependent upon on a change in classification, seniority calculations should be reviewed.
