Voiding/Deleting Registers

Due to the change in the Minimum Acceptable Qualifications the following actions are required:

- 1. Effective date for the changes will be July 15, 2007.
- 2. The registers for the Elevator Mechanic Helper I, Elevator Mechanic, Elevator Mechanic Foreman, Elevator Mechanic Helper II, and Lead Elevator Mechanic should be voided at the close of business on July 14, 2007.

Class Specification and Examination Components/Instruments

The new class specifications and revised Rating Sheets for the listed classifications will be effective July 15, 2007. There will be no changes to the content of the examinations at this time. Examination Directives

- Registers for the Elevator Mechanic Series (Elevator Mechanic Helper I, Elevator Mechanic, and Elevator Mechanic Foreman), Elevator Mechanic Helper II, and Lead Elevator Mechanic are to be voided on July 14, 2007 as a result of the new Minimum Acceptable Qualifications.
- Contact should be made to each candidate who is listed on the current employment register to request documentation that the candidate meets the new Minimum Acceptable Qualifications. Please note, any person on the reemployment register, should also be contacted to determine eligibility for return for layoff.
- Examination scores for those applicants who meet the new Minimum Acceptable Qualifications for the designated examination(s) may have their scores 'lifted' and placed on the new employment register for the designated classification(s).
- If the candidate does not meet the new Minimum Acceptable Qualification, the score must be voided and the candidate notified following standard procedures.
