Consistent with our transition to electronic testing options, the State Universities Civil Service System (System Office) is proposing revisions to the classification plan for several classifications within the Audio-Visual work area. We want to convert the current examinations to an Electronic Knowledge Test (E-Test) and/or Credentials Assessment model, which can be easily delivered in an electronic format. This conversion should prove to be more efficient and effective in addressing the applicant recruitment and employment components in this occupational area.

This proposal is to notify you of our planned conversion from the current Informational Supplement, Knowledge Test and Understanding & Following Directions Test. We may revise the classification specifications for this and similar series and will be changing the specification format to coincide with our standardized model.
