Voiding/Deleting Registers

The employment registers for the Police Sergeant and Police Lieutenant should be voided at the close of business on April 14, 2015. All testing materials related to these titles should be destroyed.

Class Specification and Examination Components/Instruments

The revised examining instruments for the Police Sergeant and Police Lieutenant classifications (Credentials Assessment and Knowledge Examinations) will be effective (available per E-Test) April 15, 2015. (Please note – in anticipation of the effective date and voiding of registers the knowledge portion of the Police Sergeant examination will be available within E-Test on March 6, 2015.)

Pay Rate/Ranges

Where necessary, employers should make adjustments to or establish new pay rates/ranges to accompany the above changes. In some instances, establishing a wide pay range will optimize the opportunity of each employer to properly reflect their individual compensation programs for these operations and positions.

Seniority

Seniority calculations should be reviewed and established based on the final classification assignment.
