Class Specification and Examination Components/Instruments

The revised examining instruments for the Police Officer classification (Physical Fitness Test, Cognitive Test (Knowledge Test and Integrity Test), and Structured Oral Interview) will be effective (available per E-Test) Tuesday, December 15, 2015. The revised examining instruments for the Police Corporal classification (Knowledge Test and Structured Oral Board will be effective (available per E-Test) Friday, January 1, 2016. Pay Rate/Ranges
