#### Voiding/Deleting Registers

The employment registers for the Police Officer should be voided at the close of business on Monday, December 14, 2015. All testing materials related to this title should be destroyed. The classification of the Police Corporal was discontinued effective July 15, 2015. The employment registers for the Police Corporal were to be voided at the close of business on Tuesday, July 14, 2015 and all testing materials related to this title were to be destroyed, at that time. Please assure that all materials were destroyed and your campus should process exam requests accordingly to the new testing standards.

### Class Specification and Examination Components/Instruments

The revised examining instruments for the Police Officer classification (Physical Fitness Test, Knowledge Test, Integrity Test, and Structured Oral Board) will be effective (available per E-Test) Tuesday, December 15, 2015. The revised examining instruments for the Police Corporal classification (Knowledge Test and Oral Board will be effective (available per E-Test) Friday, January 1, 2016. ## Pay Rate/Ranges
