Voiding/Deleting Registers

The employment registers for the Medical Records Technician, Medical Record Practitioner, and Medical Records Administrator Series classification(s) shall be voided at the close of business on Wednesday, June 30th, 2021. All testing materials related to this title shall be destroyed.

Reemployment Registers

Upon utilization of CIT Policy #1, individuals on the Reemployment Register are entitled to remain on the Reemployment Register for the classification designated to replace the previous classification or for a classification that is reasonably equivalent to the previous classification specification and examination. Reemployment Registers shall not be voided.

Class Specification and Examination Components/Instruments

The revised class specification and examining instruments for the Health Information Series classification(s) will be effective (available per E-Test) on July 1st, 2021. Pay Rate/Ranges
