## Voiding/Deleting Registers

The employment registers for the Local Area Network Support Specialist Series classification shall be voided at the close of business on August 31, 2024. All testing materials related to these deleted titles shall be destroyed.

## Reemployment Registers

Upon utilization of CIT Policy #1, individuals on the Reemployment Register are entitled to remain on the Reemployment Register for the classification designated to replace the previous classification or for a classification reasonably equivalent to the previous classification specification and examination. Reemployment Registers shall not be voided.

**Class Specification and Examination Components/Instruments**

The new class specification and examining instruments for the Local Area Network Support Specialist Series classification(s) will be effective (available per E-Test) on September 1, 2024.
